Dear Sir / Madam,

Pursuant to Regulation 30 read with Para A, Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform that Mr. Shamshad Alam (ACS: 66754) has tendered his resignation from the position of Company Secretary & Compliance Officer (Key Managerial Personnel) of the Company due to his personal reasons.

He tendered his resignation vide letter dated November 15, 2025 and shall be relieved from his responsibilities with effect from close of business hours on December 15, 2025.

Consequently, Mr. Shamshad Alam shall also cease to be the Key Managerial Personnel under the provisions of Section 203 and other applicable provisions of the Companies Act, 2013 and Regulation 30(5) of the SEBI LODR Regulations for the purpose of determining the materiality of any event or transaction for making the required disclosures to the Stock Exchange, with effect from close of business hours on December 15, 2025.

There are no material reasons for his resignation other than those mentioned above.

Further, it is clarified that the Company is presently undergoing the Corporate Insolvency Resolution Process ("CIRP") under the provisions of the Insolvency and Bankruptcy Code, 2016. In this regard, notwithstanding the resignation tendered by Mr. Shamshad Alam, his statutory, fiduciary and professional responsibilities, obligations and liabilities in relation to the CIRP, to the extent applicable under law, shall continue until the completion of the CIRP.

The Resolution Professional ("RP") expects and requires Mr. Shamshad Alam to extend full cooperation and assistance in all present and future CIRP-related matters, including but not limited to regulatory compliances, statutory filings, clarifications, records, and proceedings, as may be required from time to time. In the event of any non-cooperation or failure to provide the requisite assistance





during the CIRP, the RP shall be constrained to initiate appropriate proceedings, including filing an application before the Hon'ble National Company Law Tribunal under Section 19(2) of the Insolvency and Bankruptcy Code, 2016.




