भारतीय रिजर्व बैंक की मौद्रिक नीति समिति (एमपीसी) की तीन दिन की बैठक बुधवार को यहां शुरू हुई। माना जा रहा है कि मौद्रिक नीति समिति नीतिगत ब्याज दर को यथावत रखते हुए नरम रुख को जारी रखेगी।
